Introduction:

The St Barnabas Terraces operate as part of St Barnabas Anglican Church, Broadway, and so is managed with Christian principles in mind. Therefore, the Terraces Management requires that residents agree to and sign the Terms and Conditions as set out below. By signing this agreement residents acknowledge that the network administrator has access to data relating to individual usage and anyone found in breach of the Terms and Conditions will be subject to disciplinary action which may include permanent internet disconnection or termination of residency which would include forfeiting of bond.

Terms and Conditions

As a resident of the St Barnabas Terraces in 2018 I agree:

1. not to engage in illegal internet use. This includes, but is not limited to, pirating software, illegal access or downloading of music/video/TV, child pornography, material inciting terrorism, invasion of privacy, spamming, accessing unauthorised computers, accounts or networks belonging to another party, uttering threats or intellectual property rights' violations.
2. not to access or download any material considered unsuitable by the St Barnabas Terraces' Council. This includes, but is not limited to, pornography, sexually explicit material, obscene or indecent speech or material, hacking, material that incites violence or discrimination, defamatory or abusive language.
3. not to partake in any activities that would disrupt or interfere with the ability of others to use the network or equipment, including distribution of viruses, worms or other forms of service attack.
4. not to send any form of electronic communication, including social media, to any other residents or persons outside the Terraces which could be considered discriminatory, ie denigrates a person on the basis of race, gender, age, sexual orientation or disability.
5. not to send any form of electronic communication, including social media to any other residents or persons outside the Terraces which could be considered bullying or of a sexual nature, including obscene jokes, inappropriate photographs or suggestions of a sexual nature.
6. to ensure any device used on the Terraces' network has up to date anti-virus software.
7. to be considerate of individual internet usage, particularly at times of high demand.
8. to only use Terraces-supplied wifi units installed in each house or plug directly into a wall port to connect to the internet. (Individual routers can interfere with the overall working of the Terraces' internet and disrupt connection for everyone.)
9. that any usage of the internet carries inherent risks of security, privacy and confidentiality and that the St Barnabas Terraces is NOT liable for any virus, loss of data, file corruption or other security issues that result from transmission or download of material through the Terraces' internet network.

I understand that if I fail to fulfil these responsibilities or if I break the rules in any way, I may be refused the use of the Terraces' internet or be asked to leave, pay all outstanding debts and forfeit my bond.
